


Who are The Jetsets?

The Jetsets is an exciting new Middle East-based aviation company that pledges to redefine private jet travel across the region and around the world.



Fractional Ownership Product

The fractional owner will

- own a fraction of the aircraft
- pay for a fraction of the aircraft
- pay for his/her fraction cost of the Monthly Management fee
- pay for his/her fraction cost of the Occupied Hourly charge
- The Monthly Management fee and Occupied Hourly charge can be paid monthly or annually. If paid annually, there will be a 5% discount

- have ownership of the aircraft for 10 years
- can cancel the agreement at Year 5
- can upgrade to a newer aircraft at Year 5
- have the residual value of the aircraft if he cancels his/her Agreement anytime from Year 5 to 9



Challenge

Client, an ultra-HNI wishes to acquire the entire 1000 hours per year to retail out to his clients.

Solution


The Jetsets worked with the client's budget and searched the private jets market for the appropriate aircraft, acquired the aircraft and placed it for the sole use of the client and his customers.

As a back-up to assist the client, The Jetsets placed our Charter department on notice should the client require support to utilise his hours.

Client B



Challenge


This client wants to acquire the aircraft to take advantage of the tax benefits allowed for assets in his country. Client only requires 400 hours himself and would like The Jetsets to come up with a solution to utilise the remaining 600 hours.

Solution

The Jetsets proposed the most appropriate aircraft for the client to acquire, to take advantage of the tax benefit. The Jetsets then proceeded to sell out the remaining hours to clients on a guaranteed blockhours basis. The sale of the surplus 600 paid 60% of the running cost of the aircraft. Client very happy to have achieved both his aims of the tax benefit and effective use and cost savings that came with it.



Client C



Challenge


This client is newly introduced to private aviation and particularly to fractional ownership. He likes the idea but is worried about the 10-year contract of fractional ownership.

Solution

The Jetsets came up with a solution that enables the client to enjoy all the benefits of a standard fractional ownership but on a yearly rolling contract. Client is very happy as he is only committed to 1-year fractional contract, meaning he could decide not to renew the following year if he is not totally happy.

Client D



Challenge

Client is a very busy HNI, with business interests spread over the Middle East, Europe, US and Asia. Client must travel at short notices and wishes to save time whilst making these journeys. He only requires about 300 flying hours per year.

Solution

The Jetsets recommended a 300-hour fractional ownership for this client. The client can now travel on his personal aircraft at short notice. Whilst travelling on his private jet, he is only responsible for 30% of the capital cost as well as the management and maintenance cost. He travels safe as he only flies out and back through private terminals, having very few touch points.

Safety is an important reason, especially in this age of the pandemic, why a lot of HNIs like you are considering private aviation. Firstly, there is no queue to experience. As a private flyer, you will be the only person travelling at any time. Your luggage and passport are checked in for you by airport staff while you are sat in your limousine or in the private lounge after which you only just walk short steps to board your flight. From home till you board, you may have no touch point, so very little chance of catching COVID-19 while flying private.

Challenge


This client is a frequent private jet traveller. He wishes to have his own aircraft and he wants the aircraft financed to ease his cash flow. He has a budget in mind.

Solution

We finance aircraft purchases, as part of our services to our client. With the client's budget, we set out to procure a suitable aircraft for the client. We managed to get the aircraft that suited the client's travel needs and we financed the aircraft on terms very convenient to the client. Client very happy with the solution proffered by us and he signed a 10-year management contract of the aircraft.
